

Format for Affidavit of Undertaking by the Parent for regular admission of the child to Class 11th 2016-2017

I, _____ Father of/ Mother of/ Guardian of _____, intending to enroll my ward in Class 11th Session 2016 – 2017 in Burn Hall Hr. Sec. School, Srinagar, do hereby solemnly affirm and declare as under:

1. That my ward named above is being admitted in Class 11th of this school as a regular student of the school and I hereby declare that I will abide by the admission policy of the school in all matters.
2. That my ward will attend school regularly and will ensure minimum 85% attendance in academic year 2016 – 2017. I shall ensure that my ward will conduct himself in and outside the school satisfactorily. I will send my son / ward regularly on prescribed school time in proper school uniform, haircut and along with school diary, failing which he will be disqualified to appear in the board exams.
3. That I shall visit the school authorities intermittently and remain in touch with authorities of the school to enquire and verify discipline and academic performance of my son / ward every month.
4. The deponent further undertakes that in the event of any indiscipline, misconduct, misbehavior or involvement of the ward in any activity which has the effect of disturbing the normal functioning of the class, the deponent shall have no objection, if any, disciplinary action is initiated against the ward and the ward is accordingly dismissed/ disqualified from the school.
5. That I am aware of the fact that my ward has to pass in all the subjects securing minimum 75% marks in Medical / Non- Medical stream in class 11th Board Exam to be conducted during the academic year 2016 - 2017.
6. That I am aware of School's Code of Conduct & Discipline stated in Student's Handbook-cum-diary on page numbers 18 – 27, a copy of which is with my ward. I give the assurance that my ward will abide by it in letter and spirit.
7. That the deponent further undertakes that if my ward is involved in intimidating the school employees/ students inside the school premises or its outside, the deponent has no objection if the school authority disqualifies and dismisses my ward from the school.
8. That the deponent further undertakes that in case damage is caused to the property of the school in whatsoever manner including staining ink and writing on the wall or in the event ward carrying the weapons in the school premises, the school authorities shall be within their competence to impose fine or award any sort of punishment on the ward for which, the deponent shall have no objection.
9. That my ward shall not bring Cell/Mobile Phone or any Electronic Gadgets to the school for any reason whatsoever. If found the school management can confiscate and the same shall not be returned.
10. That if my ward is found violating School's Code of Conduct and Discipline, and any such regulations issued in the interest of general good of the students for inculcating, nurturing and maintaining the discipline, he will be liable for suitable disciplinary action which may include discharge.
11. That in no case shall I hold the school management responsible for any of the indisciplinary acts done by my ward in or outside the school.
